



## How to apply?

Candidates apply through the eVS web portal: <a href="https://portal.evs.gov.si/prijava/">https://portal.evs.gov.si/prijava/</a>

You will first be redirected to the State Administration's SI-PASS online registration and e-signature service, where you can use multiple authentication methods (username and password that you can create, or one of your electronic identities)


# **Fulfil application**

The following steps must be completed before the application is finalized:


- 1. Selection of call for enrolment and type of application
- 2. Personal information
- 3. Details of achieved qualifications
- 4. Data on desired study
- 5. Supplemental documents
- 6. Review and submit the application

- ➤ Click a large submit button. You will be notified of the submitted application to the e-mail address you provided in the application.
- The application for enrollment and the related procedures will be made electronically via the eVŠ portal, including all the required supplemental documents and the notification of selection.

- Candidates who have already completed secondary education at the time of application and have proof of eligibility (final exam, secondary school completed abroad ...) and which cannot be obtained from public records, submit them electronically via the eVŠ portal **together with the application**, or at the latest by the end of the application period in which they submit the application.
- Candidates who complete secondary school in the current school year must submit evidence to the eVŠ portal by the above-mentioned date.

- > Slovenians without Slovenian citizenship
- ➤ Citizens of the Member States of the European Union and other foreign citizens who have permanent residence in the Republic of Slovenia and who themselves or at least one of their parents or legal guardians are residents of the Republic of Slovenia for tax purposes; persons who have been granted international or temporary protection and applicants for international or temporary protection who will get protection until selection date; foreign citizens who completed secondary school education in the Republic of Slovenia and passed the matura are required to apply for enrolment places announced for Slovenian citizens and citizens of the Member States of the European Union.
- > Citizens of the following non-European Union countries: Norway, Iceland, Liechtenstein and Switzerland are also treated on an equal basis with citizens of the RS and the European Union.

- 1. Apply for study via evs web portal
- 2. Add necessary documents by the deadline
- 3. Wait for an acceptance note (after closure of the application)
- 4. Wait for invitation for enrolment (check also spam folder)
- 5. Enroll by the deadline (send application form and cover tuition fee if necessary)
- 6. Apply for Temporary residence permit (at local administrative unit in Slovenia if you can enter without visa OR at the Embassy of Republic of Slovenia if you can not enter without visa)
- 7. Search for accomodation
- 8. Start your studies!
